### **SOUTH EAST AREA AGREEMENT**

An agreement between the **PCN Sport Alliance (MPNFL)** and **Frankston & District Junior Football League (F&DJFL)**

This agreement is signed pursuant to AFL Vic Country Rules and Regulations pertaining to permits and clearances and in particular clause 2.10 Area Permits, whereby interchange of players between clubs of the above mentioned Leagues may take place without a clearance or permit and is subject to any provision contained within this agreement.

#### **PROVIDED HOWEVER:**

- 1 That this agreement is in force for the **2014** Season only.
- 2 Only Players who are playing in the **F&DJFL U/16 competition** ("junior league") are to be considered or covered in this agreement.
- 3 Permits will only be issued to players who are in their last year of U16 football by virtue of age.
- 4 This agreement only issues permits to play in MPNFL U18s football and no permits will be issued to junior league players to play open-age football.
- 5 A junior league player ("the Player") may play with only one (1) MPNFL club during the course of the season ("his MPNFL club").
- 6 That prior to the first U18s match played by the player, the Player shall obtain written permission to do so from his junior league club (Form "A" attached). The permit shall be similar to a one-day permit form and dispersed by the club with which the Player plays on the day as required under regulation 2.1 of the AFL Vic Country Rules and Regulations.  
**The signed permit must be forwarded to the F&DJFL within 7 days of player playing.**
- 7 Permits applied for under this agreement must be signed by the Player's Parent or Guardian and can be applied for at any stage of the 2014 season (subject to finals' eligibility criteria).
- 8 The Player must not be played before a registered MPNFL player.
- 9 The Player shall only be granted a permit where the Player's junior league team is not playing on the day that the permit is requested.

- 10 The player is not permitted to play with both his junior league and an MPNFL team on the same day.
- 11 The player can play for his MPNFL club when his junior league team is having a bye (with the exception of finals), or has yet to commence, or has completed, their season.
- 12 The number of players that an MPNFL Club can request under this agreement shall be limited to 4 per game, and in cases where the junior league team is having a bye, or is yet to commence, or has completed, their season, then there shall be no such limit.
- 13 The player must play three (3) games with his MPNFL U18s team before he is eligible to play for that team in the MPNFL finals.
- 14 In relation to Finals, the Player is only permitted to play in one (1) finals game per weekend (including Fridays), and that one (1) finals game must be with his junior league team for as long as that junior league team is "alive" in finals, even if that junior league team is not taking to the field on a particular weekend.

**AND FURTHERMORE**

- 16 Any player reported under this agreement will be dealt with by the League he is playing in at the time of the report.

**It is further agreed that the Administration of each League shall take the necessary steps to ensure adequate** recording of the effected player's movements and shall advise, as a matter of urgency, any Tribunal decisions in cases of permit players charged with field offences.
