5. PRESIDENTS REPORT

2015 has been another busy year for the club and the committee. We have focused our efforts on completing the track widening and this has been made a priority for the coming years as well. 2016 will see the track widened and resurfaced from turn 9 to turn 12 and as funds permit we will complete the works from turn 3 to 7.

The club has submitted an expression of interest to host the National Historics Race Meeting in either 2016 or 2017. If successful this event will be a premier event for the club and be a huge boost to our income and gain us some excellent exposure on the national stage.

With the lease expiring in 2018 work and planning for the MX site is continuing with some design work for the viewing mounds underway as well as design ideas around the new main entrance layout with discussion around access for vehicles and spectators and what services will be provided on the site.

Many of our club riders have had a successful year with our national and international riders performing well.

Congratulations to them and thank you to all our club members that have entered in and ridden at ride days and race meetings, without your support and enthusiasm we would not be the club we are today.

Key Issues and Achievements for 2015

We held some very successful race meetings over the last 12 months, Master of Mac Park over two rounds, the second 6hr Scooter Race which was a great success, SA Historics race meeting which was very well subscribed and of course the seniors meeting which is always loads of fun.

The introduction of EFTPOS facilities has been welcomed by members, development of a year book which is available for purchase and the Mac Park Calendar which will be given to all members when they join or renew their membership. The MGCC held their Summer Series here enabling them to hold their annual Road Race in safety and off the main roads. After a suggestion at last year's AGM we held 3 open committee meetings for members to attend, thank you to those members for their attendance and input at the meetings. We developed a rider's brief for track days so the message to members is consistent. After a couple of false starts with the winter classic we will be running the inaugural Classic Master of Mac Park, interest in the event is building and we are hoping this will become the Premier Historic event for riders. There will be a Motorcycle only swap meet at this event as well which we hope will generate plenty of interest and visitors. After discussions with Preston MCC we will be holding a SA vs Vic challenge on the June long weekend, we hope this event will be well supported.

Our Vision for the Future

Track widening is an ongoing priority and with the widening from turn 9 to 12 set to be completed early 2016 the committee is focussed on getting the remainder of the track widened by early 2017.

A budget to complete this work is yet to be set but we will be looking at a spend of approx. 160-180k so a substantial investment.

We have applied to host the 2016 or 2017 National Historics race meeting, whilst this event creates a huge amount of work the exposure and financial gain is worth all the effort.

Design work and discussion on the development of the MX site is continuing with ideas and planning being discussed by the committee. The development of the site will provide an excellent view of the entire track as well as amenities for spectators and a dedicated entrance for all who visit Mac Park.

We are always looking for more volunteers at ride days and at race meeting and I urge all members to give some time to help out at these events to reduce the workload placed on those regular helpers. You can contact any of the committee members to let them know if you are available.

I would like to thank each and every one of the committee for their hard work and commitment to the club, with most of the committee holding office bearer positions for many years, it is only through their ongoing support and involvement that keeps this club functioning and progressing.
